If we talk about Hindu religious rites, it is Grihyasutra that the person follows towards sanskara and as per the norms and number of offerings, people use substances and mantras. Generally, differences are also seen in different families regarding worshipping, stories, and distribution of Prasad, etc. The discussion of the rites is mainly found in the Grihyasutras, but in these, the word 'sanskar' is often used in the sense of sanctification of the sacrificial material. In the Vaikhanas Smriti Sutra, first of all a clear distinction is found between the sacraments and sacrifices related to the body. On the other hand, in the context of rites in the Angveda, some hymns describe some religious acts related to marriage, conception, and funeral. Shrut Yagyas are mentioned in Yajurveda. Atharvaveda also gives a detailed description of marriage, funeral, and conception rites. At the end of education in Taittiriya Upanishad, the convocation of Acharya is received.

That is why we say that the entire system of rituals is found in the Grihasutras themselves. The first mention of marriage ceremony is seen in the Grihyasutras. After this, the rites of conception, punsavana, seemantonnayan, jat-karma, naamkaran, nishkraman, anna-prashan, chuda-karma, upanayana and samvartan etc. have been described. If the matter related to the rituals is in harmony with the practical aspects, then the rites and atmosphere of the family create the good or bad character of the child accordingly. If the seeds of good values are sown in the hearts and minds of children from childhood and they are irrigated with clean water of positive energy and excellent thoughts, then they will never be afraid, confused, and deviate from the right path at any point of life.
