INTRODUCTION

"University Social Responsibility" (USR) is a concept that refers to the social responsibility of universities or higher education institutions. It is an extension of the concept of "Corporate Social Responsibility" (CSR) that is applied to businesses and corporations. USR involves universities taking responsibility for their impact on society and the environment, and actively seeking to address societal challenges through their research, teaching, and community engagement activities. This includes promoting social justice and equity, sustainable development, and the development of knowledge and skills that contribute to the well-being of society. The exact origin of this term is not entirely clear. However, it is generally attributed to Dr. M. Beena, who is a professor at the Mahatma Gandhi University in India. Dr. Beena first used the term in an article published in 2011, where she argued that universities have a responsibility to contribute to social and economic development in their local communities. Since then, the concept has gained traction and has been discussed by scholars and practitioners around the world. The Concept of University social responsibility (USR) has been defined by Chen et al. as follows:

University social responsibility (USR), is a philosophy or principle for social movement, which can be perceived as a philosophy of a university to use an ethical approach to develop and engage with the local and global community in order to sustain the social, ecological, environmental, technical, and economic development. USR acts as a key player for social changes, as USR implies having a policy of ethical quality, governing the performance of the university community. (Chen et al.)

Discussing the importance of the concept of University Social Responsibility (USR) in an article entitled "University Social Responsibility (USR): Identifying an Ethical Foundation within Higher Education Institutions" Chen et al. write, "UNSECO believes that education is a key to social, economic, and environment development, and is also a key in the creation of learning societies and achieving a sustainable future (UNESCO, 2007). Higher education institutions (HEIs) have been perceived as a root that connects local setting to a larger international field of knowledge." (Chen et al.)

There is a growing recognition that universities have a role to play in addressing societal challenges, and that social responsibility is an important aspect of their mission. By engaging in socially responsible activities, universities can contribute towards creating a more sustainable and equitable world, while also enhancing their reputation and meeting stakeholder expectations. Asserting the need for USR along with CSR Tara Panjwani writes:

USR and CSR are intrinsically connected with the common denominator being the people and the community. Despite this connection, more often than not, both USR and CSR tend to operate in silos in a static and disconnected manner. However, in today's rapidly changing and increasingly interdependent world, no organisation (be it an educational institution or a business) can survive or sustain itself over the long term if it is not socially responsible and if it is not collaborating. 1. University Social Responsibility and its Impact on Society

In today's world of global challenges such as climate change, large-scale population movements and new learning spaces and working methods, higher education institutions (HEIs) are under immense strain to remain relevant and provide quality education. Given these shifting conditions, universities are increasingly engaging in USR activities. Yet despite its importance for university strategy and operations, there is a paucity of systematic research on its implementation across different countries.

(a) Education: University social responsibility (USR) has become a worldwide issue for higher education institutions. From new learning spaces and working methods, to climate crisis issues, large-scale population movements and diversity within publics, universities are confronted with an array of societal difficulties. One of the greatest societal challenges faced by higher education is realizing its "third mission," which entails contributing to socio-economic and regional development, creating social capital, instilling responsible citizenship, strengthening local/regional/national community cohesion and participation in social and cultural life. USR plays an essential role in this regard - one which needs to be strengthened for it to reach its full potential. Recently, several CSR initiatives have been launched with the goal of encouraging more ethical and responsible living. These include socially responsible advertising, employee volunteer programs and a social impact investment strategy. Many companies, both large and small, are increasingly taking a stand for social responsibility. Companies such as Havells and Tanishq Jewellers have created advertisements that advocate gender equality and respect for women; Mahindra Group has even opened five schools in India offering vocational training to the poor.

Universities must ensure they educate students about CSR and incorporate it into their curriculums. Doing this will prepare them better for professional careers that require them to engage in issues such as climate change and inequality. Furthermore, it will encourage students to become actively involved in addressing local issues, leading to greater awareness of how they can contribute. This is especially pertinent at a time when the most connected generation has grown up with access to an abundance of knowledge and opportunities to

In addition to teaching these issues at the local level, universities must also conduct research into these areas and integrate study of these topics within their curriculums. Doing so will give students the skills needed to respond effectively to social crises while guaranteeing their university has a strong socially responsible approach at its core.

(b) Health

University social responsibility (USR) is an emerging research field that has gained momentum among academics and practitioners alike. USR strives to extend the traditional mission of universities by developing solutions for economic, social, and environmental problems through dialogue with community members. Furthermore, it strives to produce socially responsible students who are aware of their responsibilities beyond campus boundaries. Many authors have examined the effect of University social responsibility on health and environment. These studies demonstrate that University social responsibility is an essential element in higher educational institutions' success; it enables them to promote a more balanced, sustainable society through activities which go beyond simply raising awareness; they can actually effect positive changes in community development in terms of social, economic, and environmental aspects. n this regard, it is essential to comprehend how universities set their objectives, strategic actions and goals in order to satisfy various stakeholders such as students, institutions, government, companies and local communities. The theory of stakeholder management provides insight into these influential groups and helps us comprehend their interests and needs.

Another factor to consider is the variety of ways USR is implemented in HEIs. There are three approaches: managerial, transformational and normative - each with their own specific features. One major challenge faced by Higher Education Institutions (HEIs) is a lack of understanding about USR and how it influences students' attitudes toward this concept. To combat this issue, HEIs must ensure students have enough information about USR and how it applies to their lives.

To this end, a survey was conducted by independent agencies on students from India and Croatia with the purpose of analyzing perceptions and attitudes toward USR in both countries through an intercultural framework. A total of 1340 students took part in this research project; results revealed that most were aware of USR but their attitudes differed significantly between both countries studied.

(c) Environment

Universities play a pivotal role in providing educational experiences that promote social responsibility and justice, as well as creating social capital by indoctrinating students with democratic citizenship skill sets. Many students are concerned with environmental

Furthermore, companies must know how they can become more efficient when using resources. University Teknologi Brunei, for instance, has successfully reduced its greenhouse gas emissions through initiatives such as green roofs and recycling.

Universities can play a significant role in social responsibility by conducting research into global and local crises that require attention, as well as by supporting students' efforts to solve these problems. Doing so creates an environment of sustainability and wellbeing for all those involved. A university can utilize their expertise and resources to promote socially responsible practices within companies. This could include working on projects that promote sustainable practices or conducting internal research into responsible management and leadership practices. UKIBC's Sector Advocacy Group is championing effective international collaboration in India's Higher Education system and connecting business needs there with UK graduates on a long-term, sustainable basis. This initiative is essential for both sides of the equation as it will allow universities to continue their mission of education and development while allowing businesses to grow.

Taiwan recently initiated a program in 2018 to encourage universities to contribute to local community development. Dubbed "University Social Responsibility Projects," these initiatives encourage schools towards people-centric approaches grounded in local requirements. Finally, universities can become more socially responsible in a variety of ways that are essential for maintaining an efficient ecosystem between industry, academia and individuals. These include practical measures like encouraging staff to recycle more and making healthier food choices that promote ethical values.

(d) Poverty

University Social Responsibility (USR) is the capacity of a university to make an impact on society by fulfilling four essential processes: management, teaching, research and community engagement. It plays a significant role in higher education by contributing to socio-economic development and helping universities meet sustainable development goals. Furthermore, USR serves to enhance universities' public image as well as increase their competitiveness. USR (Universities for Sustainable Resilience) has become a third mission for universities, alongside education and knowledge creation. In an increasingly aware world that faces environmental, social, and economic difficulties, USR is becoming an integral component of universities' missions as they demonstrate their social responsibility.

In India, USR (Universal Student Reward System) is an integral component of higher education and a significant factor in drawing students to universities. For instance, The University of Leicester's "Upskilling for Twenty First Century" initiative addresses social

The implementation of the EFLU Green Campus Initiative: This initiative aims to promote sustainable practices and environmental stewardship on campus, such as rainwater harvesting, solar energy, and waste management. One of the greatest initiatives taken in this direction is "the plantation for developing Miyawaki forests, which was formally launched by EFLU vice chancellor and UGC New Delhi member Prof E Suresh Kumar behind the Basheer Hostel, is a joint initiative of Microsoft and EFLU." (India and India) The advantages and the motive behind growing the Miyawaki forests was stated by the Vice Chancellor Prof E. Suresh Kumar who said, "Miyawaki forests are being grown to increase dense urban forests on small patches of land, adding to the lung space of the campus. Miyawaki forests grow faster and take shape as dense forests in a lesser amount of time compared to conventional forests." (India and India)
- 2. **Launch of English Pro App**: The English Pro App is an innovative initiative by the English and Foreign Languages University (EFLU) to provide language learning opportunities to a wider audience, beyond the university campus. It has been described as

a free mobile app that offers language learners an opportunity to improve their English pronunciation as part of its University Social Responsibility (USR) initiative. The app is suitable for anyone who has completed at least five years of schooling with English as a curricular subject. It teaches General English pronunciation using a unique *Bharatiya* approach, which aids the smooth transition of beginner-level English users from their mother tongue to English and promotes the use of Standard Indian English. EnglishPro can be used as a skill-enhancement or complementary course to other skill-based courses to enhance employability skills. Moreover, teachers can also use EnglishPro to support classroom teaching of English in Indian schools.

The app was launched by The Union Minister of Education Dr Ramesh Pokhriyal 'Nishank' (The New Indian Express) The app is designed to help learners improve their English language skills through engaging and interactive content that is tailored to their individual needs and learning goals. The English Pro App offers a range of features, including:

- (i) Personalized learning: The app uses artificial intelligence (AI) and machine learning algorithms to provide personalized learning experiences that are tailored to the needs and goals of individual learners.
- (ii) Interactive content: The app includes a range of interactive content, such as videos, audio clips, and quizzes, that make learning engaging and fun.

- (iii) Progress tracking: The app tracks learners' progress and provides feedback on their performance, helping them to identify areas for improvement and set achievable goals.
- (iv) Community engagement: The app includes a social learning platform where learners can connect with other learners, share their progress, and collaborate on language learning activities.
- (v) Accessibility: The app is designed to be accessible to learners with disabilities, and includes features such as closed captioning and voiceover support.
- (vi) The English Pro App is available for download on both Android and iOS platforms, and is free for all users. The app has received positive feedback from users, and has been recognized for its innovative approach to language learning.
- (vii) The incorporation of social responsibility into the curriculum and teaching methods, which enables students to understand and address societal challenges through their language and communication skills.

Overall, EFLU has demonstrated its commitment to promoting social responsibility through its various initiatives and programs. The university's efforts in USR are aligned with its core values and mission, and reflect its vision of promoting multilingualism, cultural diversity, and social justice.

6.
