He mentioned openly about the twenty-seven lovers he had in his life. According to his perspective, he never wanted to make any women sad who fall for him, he believed that each women had a certain role to be played and leave like an actor who plays her role in the stage as in drama.

In the surface perspective of Indian society, were everything looks smooth in their life from outside. Tulsi is no exception, In The Poison of Love, Meera clearly defines the state of highly educated, unemployed, married Indian woman's fundamental issues. Here, Tulsi who is webbed between sophisticated Indian tradition and rise to the modernity of her journalist husband. The women trapped in the hands of love that could even react to the deeds of her husband "seeing the ex-girlfriend resting against Madhav's chest and sharing her sorrows." Meera portrays clearly about the helplessness of an unemployed housewife who once was a brilliant IITian. She was manipulated, humiliated, and significant power of family imbalance as she was controlled over their damaging physical violence. She was just used as an object to showcase and termed as wife.

But once, she came to know from her husband that he was going to be father of another child with other women "My man. He was going to be father once more" (89). She got all the courage to kill her own children who completed her womanhood only to purify her husband with barrier of separation before signing the divorce petition. In the Indian society marriages and motherhood remain the priority of every girls life however liberated she may be from the time of immoral role of sacrificing, loving mother and wife which are assigned duties of womanhood. By this she demolished the typical concept of Indian ideal women, image of mother.

In The Poison Of Love, Tulsi is cursed by her own parents, she was fully shattered being a wife, who was helpless and at last to kill her own children to win over her husbands betrayal. Even in this modern secular India, women are not equally treated even at their homes. As she was unemployed, she was fully depended on her husband. Through the character Tulsi, Meera is portraying thousands of Indian women who are still in the four walls of the house who are silently accepting their fate of betrayal. And finally her quest for the self realization made her to become Meera of Krishna in Vrindhavan but was find stuck in the turmoil of the past life which haunted her throughout.
